

ADDENDUM NO.1

The Invitation to Bid entitled Playground Equipment for Sherwood Acres Elementary, Jackson Heights Elementary and Lincoln Magnet Elementary Bid No. 06-FAC-016 as prepared by Dougherty County School Systems Facilities and Capitol Project Services, are hereby amended to the following particulars:

1. Add the Statement of Assurance form, in its entirety, (consisting of 1 page) entitled "Statement of Assurance Form", attached to this Addendum NO. 1.
2. Add Clarification for Border Specifications: The border timbers need to be plastic interlocking timbers. Need to have smooth rounded corners to prevent pinching fingers at the joints, and 3/16" double wall construction. Each border timber needs to come with two 30" galvanized-steel installation stakes.
3. The playground equipment will need to be delivered to each site. Sherwood Acres Elementary and Lincoln Magnet Elementary will be ready to be installed once the equipment is delivered. If the site is available, Jackson Heights will be installed at the time of delivery. If the site is unavailable, the equipment will be delivered to our offices at Dougherty County School System Facilities Maintenance Department; 1711 Schilling Avenue, Albany, Georgia 31705.
4. It is the responsibility of vendor to coordinate with the utility company to locate any underground utilities before the installer begins work.
5. In Attachment A, Specifications for Playground Equipment, under General Specifications, section Play Structures, replace Structure (500-0403 Playmakers) with Structure (500-0605 Playmakers).
